Chairman Bill Mahomes convened a special telephonic meeting of the Board of Regents of The Texas A&M University System at 10:00 a.m., Friday, November 17, 2023, in the Board of Regents Meeting Room, on the campus of Texas A&M University, College Station, Texas.

RECESS TO EXECUTIVE SESSION

Chairman Mahomes said the Board would recess to executive session to consider matters as permitted by Chapter 551, Sections 71 and 74 of the <u>Texas Government Code</u> and in accordance with the law, no final action, decision, or vote with regard to any matter considered in the executive session would be made or taken.
